UNDERTAKING AND INDEMNIFICATION

- 1. I, certify that I am the bonafide guardian of the child.
- 2. In the event of my ward being admitted in the school, I shall have no objection to any medical aid being given by the school in case of any emergency, or injury, due to any cause; or inoculation against Typhoid, Cholera and Vaccination against Small-Pox to my child from year to year.
- 3. In the event of my ward being admitted to the school, I shall abide by the School's rules and procedures in all respects. I understand that the decision of the Principal / Management shall be final and binding on me.
- 4. If at any stage, it comes to the knowledge of the Principal / Management of the school that any information submitted is false or misleading or misrepresentation has been done, the Management shall be within its rights to refuse / terminate the admission at any stage without any cause or action on the part of the Applicant / Student / Parent / Guardian as the case may be, and no fee including security etc. as deposited shall be refunded.
- 5. I also declare that in case of any (God forbid) mishap / accident in the school premises and / or in the school transport, if the child is using the same, or due to any medical aid (as per clause No. 2, above) beyond the control of the Management, I shall not hold the school responsible for any claim / damages or other action in any way what so ever, and the school is hereby indemnified from all such actions and claims etc.
- 6. The rules and conditions in the Prospectus of the school have been read and understood by me and I shall abide by the same.
- 7. I will co-operate with the school in all matters including attending PTMs and sending my ward regularly to the school.
- 8. I understand that registration does not guarantee admission.
- 9. Students of class XI & XII would be considered as Day Scholars. (Timings: 07:00 am to 05:00 pm or as may be decided by the school authorities from time to time).

- 10. The Management will be within its absolute rights to take decision to terminate the admission of my ward at any stage when the Management of the school finds that my ward is:
 - a. Continuously showing weakness in studies, despite the school's effort to help the child.
 - b. Absent without sanctioned leave.
 - c. Having behavioural problems which persist despite the school's efforts, warnings to the student and / parents.
 - d. Having behavioural traits detrimental to the class / school's atmosphere.
 - e. Over-age for any class.
 - f. Detained twice in the same class.
 - g. A defaulter in payment of fees or recurring irregularity in payment as per prescribed schedule.
 - h. Guilty of moral breach considered serious by the school.
 - Non-serious and persistent in negligence of school programmes, regulations and class / home work given by the school from time to time.

NOTE: Keeping the safety of children in mind, exemption from the school bus is available only if the parents use their personal vehicle or the residence is out of school route. In all other cases, ONLY SCHOOL BUS will have to be used. NO POOLED RICKSHAW/ VEHICLE ARE ALLOWED TO CARRY THE STUDENTS.
