

THIS INDENTURE made at Delhi on the 1st June 1981 between the Delhi Wakf Board, a Board duly constituted under Wakf Act, 1954 (hereinafter referred to as the LICENSOR) and the World Education & Development Organisation, Kh.No.533, North of Humayon Tomb, Mathura Road, New Delhi (hereinafter referred to as the LICENSEE).

WHEREAS the Licensor is in possession of a piece of land bearing Khasra No.532, measuring 1 bigha 12 biswas adjacent to Khasra No.533, behind Humayon Tomb, Nizamuddin, New Delhi, as specifically demarcated by red line in the attached site plan.

WHEREAS the Licensee, a Society registered under the Societies Registration Act is running an English Medium School under the name and style of New Horizon School, and whereas due to its increased activities the plot earlier allotted is not sufficient for the improvement and additions in the classes.

AND WHEREAS the Licensor above named, in view of the educational objects of the said Society and with a sense of general interest of the community has agreed to give the aforesaid Wakf land to the Licensee on the following terms.

1. That the land referred to above has been given by the Licensor to the Licensee on Licence for running specially

and educational institution thereupon on a nominal Licence fee of Re.1/- per annum.

2. That the Licensee will not be entitled to use the Wakf land for purposes other than those categorically mentioned above.
3. That the Licensee will be authorised to raise structures/constructions with prior permission/consent of the Licensor and the permission of the Municipal authorities if so required at their own cost and expenses.
4. That the Delhi Wakf Board will be deemed to be one of the Founder Member of the said institution and a nominee of the Delhi Wakf Board shall always be included in the Managing Committee of the School as member.
5. That the Licensee shall bear/pay all the Municipal/local/revenue and such other charges/taxes as the same may be due/accrue from time to time in respect of the Wakf land/structures/constructions thereupon.
6. That the Licensee shall abide faithfully and honestly in letter and spirit, the aforesaid terms of this deed.
7. That failure on the part of the Licensee shall entitle Licensor to revoke the Licensee and to take possession of the said land.

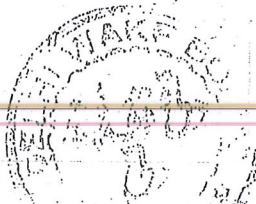
