CBSE Issues Fresh Norms For Graded Response To Ragging

New Delhi: Central Board of Secondary Education has issued a fresh set of guidelines to curb incidents of bullying and ragging in schools. It says "the responsibility of preventing any undesirable aspect of bullving and ragging rests on all stakeholders, which includes the head of the institution teacher, nonteaching staff, students, parents and local community".

For the first time, the board recommends a "graded" response system to address the cases of bullving. It says, "A comprehensive guidelines may be developed for school management, which includes various actions and penalties which may be taken as per observation and understanding the gravity of the misconduct."

These actions include verbal/written warning, suspension from attending classes/school for a specified period, withholding or cancelling the results, imposition of fine up to a specified amount an finally expulsion/rustication from school in rarest of rare cases. The option of transferring a student from one school to another may also be looked into, the board says.

According to the guidelines issued on Monday, boards with a message of strict prohibition of bullying and ragging should be displayed prominently on the campus. Other measures include con-

stitution of an anti-bullying committee and mandatory inclusion of topics on sensitization and prevention of bullying in schools in the curriculum for teachers' training.

The latest move comes in the wake of the growing menace of ragging across the country. Incidents like the suicide attempt by the son of a Bihar minister after he was allegedly ragged at a prominent residential school in Gwalior or a Kolkata schoolboy being forced to drink urine by classmates have been widely reported by the media.

Taking a serious note of such incidents, CBSE says, "Recent research in school
